International Trade and European Economic Revival, 1000-1400: Lessons for Our Times

Course Description: At a time when nationalism and protectionism are once again on the rise, it is worth examining how international trade has shaped the historical evolution of economic and social development. Instead of drawing more recent comparisons with the Great Depression of the 1930is, or the Great Recession of 2008, we take a longer view to examine the impact of changes in international trade in Europe from the fall of the Roman Empire to the dawn of the European Renaissance. The course will provide systematic coverage of the political, economic, financial, and environmental dimensions of economic activity, and governance in the European Middle Ages. Emphasis will be given to understanding how institutional evolution affected the generation and transmission of knowledge, and thus the speed and shape of Europe's economic revival. From this perspective, we draw implications for the current climate of international relations and trade.
