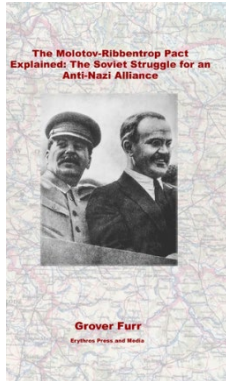


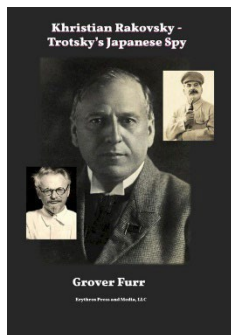

The Molotov-The Molotov-Ribbentrop Pact Explained: The Soviet Struggle for an Anti-Nazi Alliance

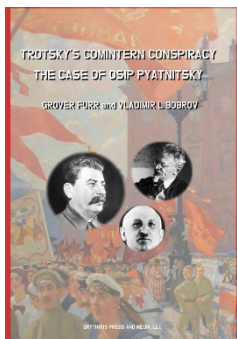

The leaders of the U.K., France, and Poland feared their own working classes far more than they did German domination of Europe. Seeing Hitler as a bulwark against communism, they encouraged him to attack to the East. Grover Furr outlines Soviet efforts to create an anti-Hitler alliance and how the politicians of the West betrayed their own people by encouraging Hitler to dominate the European mainland – a betrayal ultimately stopped only at the gates of Moscow by the Red Army.



Khristian Rakovsky - Trotsky's Japanese Spy

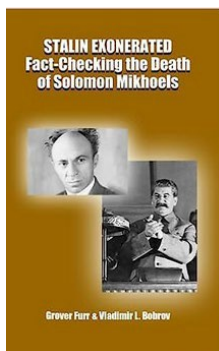
Khristian Rakovsky was a lifelong supporter and collaborator of Leon Trotsky's. In the 1920s Rakovsky occupied important posts in the Soviet government and joined the Trotskyite opposition. He was exiled to a series of provincial cities for his opposition activity. In 1934, 1936, and 1937 Rakovsky wrote statements in which he claimed to have abandoned Trotskyism.

This study concludes that, on the evidence, there can be no doubt of Rakovsky's guilt in serving as Trotsky's agent in Japan and in espionage for Japan against the Soviet Union, and no doubt of Trotsky's guilt as well.



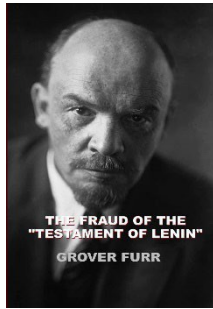
TROTSKY'S COMINTERN CONSPIRACY - THE CASE OF OSIP PYATNITSKY by Grover Furr and Vladimir L. Bobrov.

We examine the conspiracy within the Comintern by studying the investigation file of Osip Aronovich Pyatnitsky, head (secretary) of the Executive Committee of the Communist International (ECCI) from 1923 to 1935. 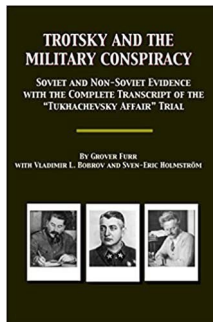

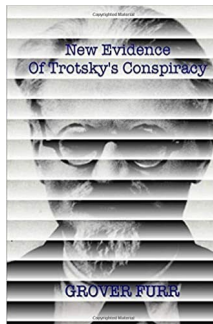
THE FRAUD OF THE 'TESTAMENT OF LENIN'. Based on the research of Valentin A. Sakharov.

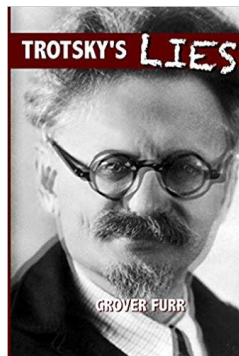
TROTSKY AND THE MILITARY CONSPIRACY by Grover Furr, Vladimir L. Bobrov, and Sven-Eric Holmström.

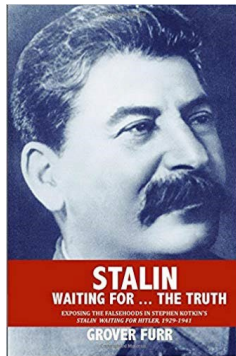


TROTSKY'S LIES. *

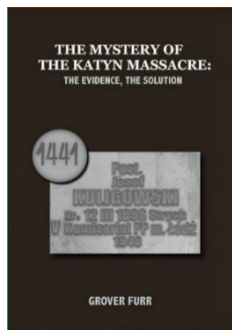
This prompted Grover Furr to check for other evidence of Trotsky's lies in his own writings and in documents from former Soviet archives.

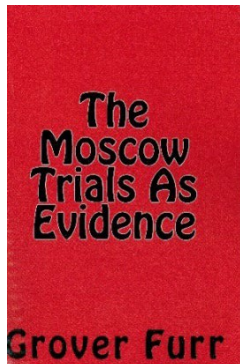

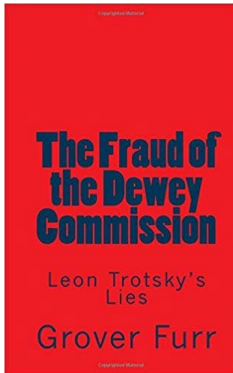


THE MOSCOW TRIALS AS EVIDENCE.*

The confessions of the defendants in the three public Moscow Trials of August, 1936, January, 1937, and March, 1938, are conventionally dismissed as fabrications, forced by torture or threats from helpless defendants. But there has never been even a shred of evidence that this is so.

Grover Furr has studied the transcripts of the Moscow Trials carefully, and has checked those statements made there against the much greater evidence we now have, mainly from the Trotsky Archive at Harvard and the former Soviet archives. THE FRAUD OF THE DEWEY COMMISSION: Leon Trotsky's Lies.*



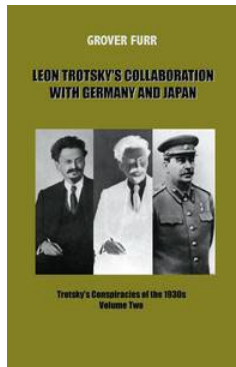

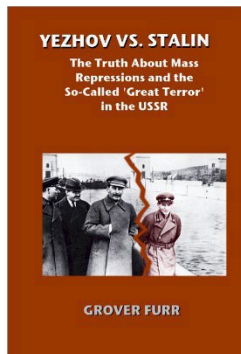

In this book, Furr conducts an expert, objective study of the evidence. He concludes that **Trotsky did indeed collaborate with the Germans and Japanese.**

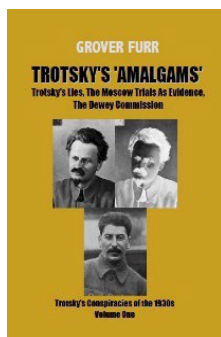
The proof that Trotsky was guilty of collaboration with the Nazis and Japanese dramatically changes our understanding of Soviet history of the 1930s.

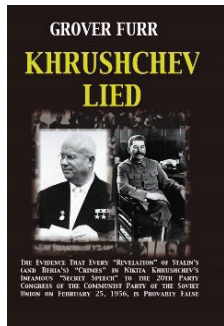

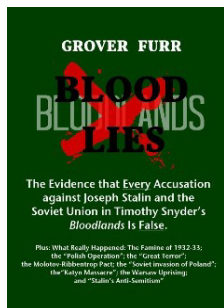

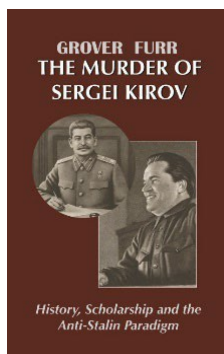
