Hi Hari,

I don't want to pre-empt Paul to whom you addressed your comments but since they are of interest to to all of us and I value your contributions, allow me to offer a reply:

- 1. You say that you "have some very serious differences with Furr. But much of his analysis certainly holds water." Specifically, which allegations? 

Dear Marv:

- 1. As always your notes require detailed work to reply. Appropriately you ask for details. I am myself handicapped right now in doing that as I am travelling on work matters. So please allow me time to respond. However two simple points.
- 2. The canard keeps coming up, for obvious reasons that the court trials were a sham. The spirited defence and evasions of Bukharin on the stand, are always discounted.
- 3. The archives have been systematically cleaned by the Khruschevites. But some data remains. You will no doubt accept that William J Chase, a respected investigator is <u>not</u> a "Furrite". . . Indeed he is not even a MList as far as I can judge. Regrettably I have never met him.

But - This is from his work. He produces work slowly, but is invariably worth watching.

"Smirnov regularly organized clandestine meetings of Trotskyists, at times in his apartment, where they debated and decided upon political activities and tactics and organized a small operational center. In 1931, he was allowed to travel to Berlin, which suggests that party leaders believed that he had broken with the Trotskyists. He had not. There he met with Sedov, Trotsky's son, with whom he discussed the Opposition's activities and his views on Soviet state policies and rising popular dissatisfaction. Smirnov's comrade, Goltsman, also visited Sedov, from whom he received Trotsky's approval to form a "bloc" with other oppositionists, including the Zinovievites, and to use various methods, including terrorist methods, to remove Stalin. Sedov served as Trotsky's proxy; doing so provided his father with plausible deniability against any charges. Trotsky always denied approving the bloc, but evidence from his own archive makes clear that he did so (Broué 1980; Getty 1986). Not until early 1936 did the NKVD and Stalin learn of the bloc and its intentions. . . For their part, Trotsky and Sedov W restling with Aspects of Interwar Stalinism 105 denied the accusations against the key defendants (Smirnov, Goltsman, and Valentin Olberg). Many Western writers have taken their denial at face value. . . From January 30 until April 27, 1930, Trotsky wrote at least fourteen letters to Olberg, each in response to letters from Olberg. Those letters make clear that Trotsky treated him as a trusted supporter (Trotsky 1975, 210–15; RGASPI, 495/205/8318, 243–46). The confiscated correspondence, which is now available, includes forty-three letters and postcards from Sedov to Olberg. The correspondence between them leaves no doubt that they had a close working relationship and were friends. Yet after the KPD sent those materials to Moscow, Olberg entered the USSR on three occasions. In 1935, he carried a Honduran passport and went to Gorky where he secured work. Olberg's arrest on January 1, 1936

was not due to NKVD diligence. He was only arrested after an investigation in Ukraine led

to information about a Trotskyist network in Gorky, where Sedov had recommended that he contact Trotskyists there. From the time Olberg arrived in Gorky, he called himself Trotsky's "emissary," who had come to the USSR to help revitalize the Trotskyist movement.

These and other revelations shocked me and my collaborator Olga Novikova-Monterde. We have found ample evidence that Trotsky, Sedov, and their supporters lied about Olberg and invented the allegation that he was an NKVD agent. His NKVD record makes clear that he was not."

Thanks, Hari. Not an urgent question and I'll await your more considered reply.

To be clear, as I noted above, there is no dispute that Trotsky and other opponents of the regime from differing perspectives were aiming at a **political** revolution to remove Stalin. It's understandable that Trotsky contemplated a bloc with other Old Bolsheviks like Zinoviev and Bukharin to this end. However, I've never seen any evidence that either the Left or Right Opposition were working independently or together towards a social revolution which would destroy the Soviet Union and restore the old order, much less in league with fascism and imperialism, which is what is at issue here.

The long passage you quote from William Chase makes no mention of Nazi or imperial Japanese involvement. Trotsky, Sedov, and Smirnov belonged to the Left Opposition as presumably did Smirnov's friend, Goltsman. I believe Bukharin under duress confessed on the stand to conspiring against the Soviet leadership but disavowed any connection to the Axis powers and reaffirmed his commitment to the Soviet Union and the Communist cause. Certainly, I've never read anything in Deutscher, Hobsbawm, or Stephen Cohen which suggested otherwise.

I've never seen any evidence that either the Left or Right Opposition were working independently or together towards a social revolution which would destroy the Soviet Union and restore the old order, much less in league with fascism and imperialism, which is what is at issue here.

Since the overwhelming majority of the CPSU and the Soviet people supported Stalin's modernization policies and leadership, there is no misnamed "political" revolution simply to remove him. At the other extreme, the Trotsky conspiracists aimed to put him at the head of the government. Trotskyists deny that he wanted to restore the old order, so playing with the label "social revolution" is an irrelevant hypothetical which thankfully did not come to pass.

As for being in league with fascism to restore the old order, the fact is simply that the Trotskyist conspiracy made deals with Nazi Germany and fascist Japan. Of course Trotsky told his crew that these were no more than deals. Gandall's "in league with" is lurid misdirection.

To take Deutscher and Cohen at their word betrays Gandall's refusal to evaluate evidence. Deutscher was a basically sympathetic biographer of Trotsky and Cohen was an open champion of Bukharin. That Gandall has "never read anything" by them that upsets his (ex)Trotskyist outlook has no material bearing on what actually happened.





A MODERATORS POV: As we know, Louis proscribed any discussion on "Trotskyism" vs "Stalinism". You'all have broken this decades long rule, it seems. I haven't personal problem in getting rid of this ban but I want to point out a few things.

If the discussion was like Marv and Hari's discussion, I would actually encourage this. Why? Because both of them are talking about the issues and not *personalizing* such polemics by trying to note where the other is wrong. Rather it is *strictly* around the issues at hand.

Charles comments are the *negative* example, calling out Marv *personally* and trying to prove him wrong instead of dealing with the issues alone. Charles style is not appropriate, trying to score points instead of only elucidating the issues. This won't be tolerated. We can continue this discussion for now but only if participants reject Charles' "style" and adopt as an example, Hari and Marv's. Otherwise I will shut down this discussion?

For those interested in pursuing the subject, I'm attaching a Pdf of Arch Getty's Origins of the Great Purges which I found online. Getty was a close collaborator of William Chase, the other historian of the period prominently mentioned in defence of Grover Furr. Getty opposed Stalin's demonization by Khrushchev but, unless I missed it, he attached no credibility whatever to the charges levelled against Trotsky and other leading figures in the CPSU that they were colluding against Stalin together with the Germans and Japanese. His book was written in 1986, prior the collapse of the USSR and the further opening of the Soviet archives. He and Chase continued publishing after that but AFAIK neither they nor anyone else who had access to the archives and further material from Western sources has since found support for Furr's assertions of a conspiracy linked to fascism.


